

ACRO Police Certificate Guidance

1. **Proof of your current address** - You must provide **ONE** proof of your current address from the 'Proof of current address' list at the end of the application form. Your current address is where you live now and can be outside of the UK. Any proof of address that is not in English must be translated into English. The UK driving licence paper counterpart is **not** an acceptable proof of address, even if it shows your current address.
2. **A recent passport style colour photograph** - You must upload one high quality, recent passport style colour photograph that clearly identifies you (the applicant). This photograph will be included on your Police Certificate. Your photograph should meet the same standards required for a UK passport (approximately 45mm x 35mm).
3. **Colour copies of your passport(s) / travel document / official photographic identity document** - You must upload colour copies of your passport(s) / travel document which clearly show your photograph, personal information, expiry date, nationality, machine readable zone, extension pages and signature (if applicable). Copies of other official photographic identity documents should show as many of these features as possible. We will not accept black and white copies.
4. **Any additional documents relevant to your application.** Examples include: Power of Attorney, authorisation documents, signed letter of authority, etc.
5. **A valid email address.**
6. **Your address history** - You must provide your address history for the last 10 years, including the dates you lived at the addresses. If you have lived outside of the UK for more than 10 years you will also be asked to provide your last UK address.
7. **Endorser details** - Your application must be endorsed by a suitable individual. We require your endorser's full name, occupation, relationship to you (e.g. friend, employer etc. but NOT family), a telephone number, and their email address as we may send your passport photograph to them as part of our check.
8. **UK National Insurance and Driving Licence numbers (if applicable).**

Continues...

1. Address

You will need to provide ONE document which clearly shows your name and your current address. This is where you live now and can be outside the UK.

Any proof of address not in English will need to be translated into English.

We do not accept envelopes or handwritten documents as proof of your current address.

The paper UK driving licence counterpart is not an acceptable proof of address even if it shows your current address.

International PO Boxes

If you live in a country where all post is delivered to a PO Box, we will accept a document which shows your name and the PO Box as proof of your current address.

We do not accept documents sent to a UK PO Box as proof of your current address.

BFPO addresses

If you have a UK forces address (BFPO) then you can provide one proof with your BFPO address on. Alternatively, you can provide a letter from your commanding officer to confirm you have a UK forces address.

One document that shows your name and current address, which is valid and in-date:

Full driving licence or provisional driving licence

ID card from your country of residence

Medical or health card

Immigration document

OR

One document dated within the last 12 months that shows your name and current address:

Utility bill (this does not include a mobile phone bill)

Bank or building society statement

Credit card statement

Pension letter or statement

Letter from central, regional or local government department

Letter from an employer on headed paper

Letter from a school, college or university on headed paper

TV licence

Letter from a bank

Letter from a medical service

Mortgage statement

Council tax bill or polling card

House, motor, travel or health insurance certificate or document

Letter from a solicitor

Formal tenancy agreement or letter from letting agent

4. Any additional documents relevant to your application

If The Apostilles Group are to apply for an ACRO Police Certificate on your behalf, we will need a short, dated letter written from the address you have used in point 1.

All it needs to say is:

To Whom it may Concern,

I grant authorisation to The Apostilles Group to apply for an ACRO on my behalf.

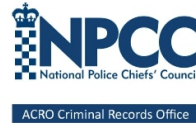
It can be written or typed but the signature must be an original, in ink signature.

7. Endorser List

In order to satisfy ACRO requirements, your application must be endorsed by an individual employed as one of the following or similar professions.

Your endorser cannot be your partner or a family member (no matter how distantly related), must have known you for a minimum of two years, and must be eighteen years of age or older.

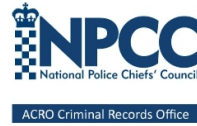
